Options for Next Steps:

- After an arrest is made, you can contact **VINE** to register to receive information about offender custody status and related court events.
- If you would like to learn about obtaining a protective order, you can contact or visit the appropriate **Hays** County District Attorney's Office (based on where you live, offender lives, or incident occurred).
- Anyone can be considered for Personal Bond, which allows an individual to be released from jail without making any kind of payment. Call the Hays County Jail at 512-393-7800 to request that someone be released on a PR Bond or discuss your concerns.
- To talk to someone about dropping charges you can contact or visit the appropriate Hays County District Attorney's Office (based on where you live, offender lives, or incident occurred). Depending on the case, charges might not be dropped.
- You may contact the KPD Victim Services Division at 512-268-3232 to speak to a Victim Services Advocate about resources, safety planning (including the use of a pseudonym), and to receive supportive guidance.
- You may call the Hays-Caldwell Women's Center at 512-393-4357 for shelter, counseling, safety planning, and children's services.
- You may qualify for Crime Victims' Compensation which helps victims of violent crime cover out of pocket expenses that are incurred as the result of the crime. Some requirements and limitations may apply. For more information call 512-396-1200 or visit www.texasattorneygeneral.gov.

Sexual Assault

If you have been sexually assaulted, you are not alone. Sexual assault is never your fault and can happen to anyone regardless of age, gender identity or expression, race, ethnicity, religion, ability, appearance, or sexual orientation. Sexual assault has a tremendous impact on you as a survivor, family, friends, and their community. Sexual

contact without consent is a crime.

- If you are a victim of Sexual Assault, you have the right to have a Sexual Assault Forensic Exam (SAFE) performed at no cost to you with or without contacting the police.
 - If you wish to have a SAFE performed with police involvement, call 911.
 - If you wish to have a SAFE performed without police involvement, call HCWC at 512-396-4357.

Rights of Crime Victims

- The rights to protection from threats of harm arising from cooperation with prosecution efforts.
- The right to have your safety and that of your family taken into consideration when bail is being considered.
- If you so request, the right to be informed in advance about court proceedings, including cancellations or rescheduling.
- If you so request, the right to information about procedures in the criminal investigations of your case by law enforcement officials, and about general procedures in the criminal justice system, including plea bargaining, restitution, appeals, and parole from the prosecutor's office.
- The right to receive information about the Texas Crime Victim's Compensation Fund that provides financial assistance to victims of violent crimes and, if you so request, referral to social service agencies that may provide additional help.
- The right to provide information to the probation department conducting a pre-sentence investigation on the impact of the crime.
- -The right to have a law enforcement agency pay for medical examinations for victims of sexual assault and request the right to counseling regarding AIDS and HIV infection and testing for sexual assault victims.
- If you so request, the right to be notified of parole proceedings by the Victim Services Section of the Pardons and Paroles Division, the right to participate in the parole process by submitting a victim impact statement or other information, and the right to be notified of the inmate's release.
- The right to be present at all public court proceedings if the presiding judge permits.
- -The right to a safe waiting area before and during court proceedings.
- The right to prompt return of any property that is no longer required as evidence.
- If you so request, the right to have the prosecutor notify your employer that the need for your testimony may involve your absence from work.
- The right to complete a Victim Impact Statement, detailing emotional, physical, and financial impact that the crime has had on you and your family, and to have that statement considered by the judge at sentencing and by the parole board prior to taking any parole action.
- A victim of a sexual assault, stalking, family violence or human trafficking may choose a pseudonym to be used instead of the victim's name to designate the victim in all public files and records concerning the offense.

Section 92.016 and 92.1061 of the Texas Property Code allows for victims of certain crimes to terminate residential leases for their safety.

NOTICE TO VICTIMS OF FAMILY VIOLENCE

It is a crime for any person to cause you any physical injury or harm <u>even if the person is a member or</u> former member of your family or household.

Please tell the investigating police officer:

- 1. If you, your child, or any other household member have been injured; or
- 2. If you feel you are going to be in danger when the officer leaves, you have the right to:

You have the right to:

- (1) Ask the local prosecutor to file a criminal complaint against the person committing family violence; and
- (2) Apply to a court for an order to protect you. You should consult a legal aid office, a prosecuting attorney, or a private attorney. For example, the court can enter an order that:
 - a) The abuser cannot commit further acts of family violence;
 - b) The abuser cannot threaten, harass, or contact you at home;
 - Directs the abuser to leave your household; and
 - d) Establishes temporary custody of children and directs the abuser not to interfere with the children or any property.

A VIOLATION OF CERTAIN PROVISIONS OF COURT-ORDERED PROTECTIONS SUCH AS (a) & (b) ABOVE IS A CRIMINAL OFFENSE.

Under Section 71.004 of the Texas Family Violence Code and Section 92.016 of the Texas Property Code, survivors of family violence may terminate their lease early and avoid responsibility for future rent or fees related to breaking the lease. Survivors of family violence must provide at least 30 days of written notice to move out.
